Terms and Conditions: -

1. The intending Bidder shall quote its rates in the format provided in the BOQs for the Work uploaded to the NLSIU website. The Bidder or its Authorised Representative shall sign each page and affix the seal of the firm alongside.
2. The sealed envelope should clearly superscribe "Quotation for proposed civil works at ground floor, Yamuna Hostel", and shall be addressed to "The Finance Department, National Law School of India University, Gnaa Bharathi Main Rd, Opp NAAC, Teachers Colony, Nagarabhavi, Bengaluru, Karnataka - 560072". The sealed envelope shall be submit in person to reach this office on or before the due date mentioned.
3. The quotations received after the due date will not be entertained.
4. The GST Registration number and PAN number of the Bidder shall be mentioned in the quotation. Quotation without this information will not be accepted.
5. The Bidder shall be quote materials in accordance with the specifications mentioned in the List of Approved Makes of Material/Equipment uploaded as part of the Bid documents,
6. The Bidder should provide a Minimum Warranty of one (01) year for work.
7. Rates quoted by the bidders shall be inclusive of GST and all applicable taxes. Income Tax and all other statutory deductions like labour cess etc. will be deducted from the payments made as per prevailing rules.
8. The Rate quoted by the Bidder shall remain valid up to ninety (90) days after its acceptance by NLSIU.



9. Bidder's quoted Rates/Prices for executing the Work shall remain firm till completion of the entire work & shall not attract any escalation under any circumstances whatsoever.
10. The University shall issue a Letter of Award (Work Order) the successful Bidder ("Selected Bidder") within seven (07) days of opening of the quotations. The Work Order shall consist of the complete terms and conditions, Bill of quantities, List of Approved Makes of Materials/Equipment, and drawings, if any. Acceptance of the Work Order by the Selected Bidder shall form a binding contract with the University.
11. Date of start of work shall be reckoned from the date of the issue of the Work Order.
12. No advance payment will be made to the Selected Bidder. The payment shall be paid within 30 days from the date of supply of material on the receipt of the Tax Invoice. No interest will be paid for delayed payment if any.
13. Retention Amount at the rate 6.5% of the value of the work done for each running account bill will be deducted. The Retention amount will be released to Contractor after completion the defects liability period of 365 days. The retention amount shall not bear any interest whatsoever.
14. The material(s) supplied by the selected Bidder should be strictly as per the specifications in the List of Approved Makes of Material/Equipment, without which the material will be rejected. In case of rejection of material, one more chance given for its replacement with the material conforming to the requisite specifications. Any failure of the Selected Bidder to supply materials as per the specifications will result in NLSIU debaring the Bidder from participation in future bids for a minimum period of one year.
15. This University reserves the right to cancel this enquiry at any time without assigning any reason.
16. The terms and conditions stipulated in this Notice Inviting Quotations are binding on the Bidder.
