NOTICE INVITING QUOTATIONS

The National Law School of India, Bangalore ("NLSIU") is a University established under the National Law School of India Act, 1986, imparting legal education. Terms and Conditions: -

1. The intending Bidder shall quote its rates in the format provided in the BOQs for the Work uploaded to the NLSIU website. The Bidder or its Authorised Representative shall sign each page and affix the seal of the firm alongside.
2. Any clarifications on the quotation process may be sought by email from the University Engineer at procurement@nls.ac.in up to 5.00 pm on 08.10.2021.
3. Interested bidders may visit and examine the site to acquire the requisite information relating thereto as affecting the quotation upon writing to the University Engineer at procurement@nls.ac.in up to 5.00 pm on 08.10.2021.
4. The sealed envelope should clearly super scribe "**Quotation for Supply and Installation of Hybrid Solar & Heat Pump System at NLSIU**", and shall be addressed to:

The sealed envelope shall be submit in person to reach this office on or before the due date mentioned.

5. The quotations received after the due date will not be entertained.

6. The GST Registration number and PAN number of the Bidder shall be mentioned in the quotation. Quotation without this information will not be accepted.
7. The Bidder shall be quote materials in accordance with the specifications mentioned in the List of Approved Makes of Material/Equipment uploaded as part of the Bid documents,
8. The Bidder should provide a Minimum Warranty of two (02) years for the Work and a Minimum Warranty of ten (10) years for the new tanks supplied.
9. Rates quoted by the bidders shall be inclusive of GST and all applicable taxes. Income Tax and all other statutory deductions like labour cess etc. will be deducted from the payments made as per prevailing rules.
10. The Rate quoted by the Bidder shall remain valid up to ninety (90) days after its acceptance by NLSIU.
11. Bidder's quoted Rates/Prices for executing the Work shall remain firm till completion of the entire work & shall not attract any escalation under any circumstances whatsoever.
12. The University shall issue a Letter of Award ("**Work Order**") the successful Bidder ("**Selected Bidder**") within 7 days of opening of the quotations. The Work Order shall consist of the complete terms and conditions, Bill of quantities, List of Approved Makes of Materials/Equipment, and drawings, if any. Acceptance of the Work Order by the Selected Bidder shall form a binding contract with the University.
13. Date of start of work shall be reckoned from the date of the issue of the Work Order.
14. The University shall make an advance payment of 30% of agreed fee to the Selected Bidder upon issuance of the Work Order. NLSIU shall subsequently issue 30% of the agreed fee to the Selected Bidder upon successful delivery of materials, and 40% of the agreed fee upon satisfactory completion of the work.
15. The material(s) supplied by the selected Bidder should be strictly as per the specifications in the List of Approved Makes of Material/Equipment, without which the material will be rejected. In case of rejection of material, one more chance given for its replacement with the material conforming to the requisite specifications. Any failure of the Selected Bidder to supply materials as per the specifications will result in NLSIU debaring the Bidder from participation in future bids for a minimum period of one year.
16. This University reserves the right to cancel this enquiry at any time without assigning any reason.
17. The terms and conditions stipulated in this Notice Inviting Quotations are binding on the Bidder.
