NOTICE INVITING QUOTATIONS

The National Law School of India, Bangalore ("NLSIU") is a University established under the National Law School of India Act, 1986, imparting legal education. Sealed quotations for Supply and Installation of Cross link Fence with Gate around Sports field at NLSIU ("Work") are hereby invited from eligible contractors by the undersigned, subject to the terms and conditions enumerated hereunder.

Terms and Conditions: -

- 1. The entire Work shall be carried strictly as per specifications and workmanship manner and as per standard practice.
- 2. The intending Bidder shall quote a consolidated amount for the enclosed specifications (Annexure 1). The Bidder or its Authorised Representative shall sign the Quote Sheet (Annexure 2) and affix the seal of the firm alongside.
- 3. Any clarifications on the quotation process may be sought by email from the Procurement team at procurement@nls.ac.in up to 5P.M on_24.11.2021.
- 4. Interested bidders may visit and examine the site to acquire the requisite information relating thereto as affecting the quotation upon writing to procurement@nls.ac.in up to 5P.M on 23.11.2021.
- 5. The sealed envelope containing signed copies of Annexure 1 and Quote Sheet should clearly superscribe "Quotation for Supply and Installation of Cross link Fence with Gate around Sports field at NLSIU", and shall be addressed to "Finance Officer, Finance Department, National Law School of India University, Gnana Bharathi Main Road, Nagarbhavi, Bengaluru, Karnataka 560072". The sealed envelope shall be sent to reach this office on or before the due date mentioned, either in person or by Registered Post.
- 6. The quotations received after the due date will not be entertained.
- GST Registration number and PAN number of the Bidder shall be mentioned in quotation.

- 8. Interested Bidders must meet all qualifications mentioned in Λnnexure 3.
- 9. The Bidder should provide a Minimum Warranty of one (1) year for the work carried out
- 10. Rates quoted by the bidders shall be inclusive of all applicable taxes (except GST). Income Tax and all other statutory deductions like labour cess etc. will be deducted from the payments made as per prevailing rules. No interest will be paid for delayed payment if any.
- 11. The Rate quoted shall be firm and fixed till completion of the entire work & shall not attract any escalation under any circumstances whatsoever.
- 12. The University shall not bind itself to accept the lowest quoted rate. The University shall accept the quotation that is in best interests of the University, as determined by the University authorities. The University reserves the right to not accept any of the Quotations submitted during this process.
- 13. The Rate quoted by the Bidder shall remain valid up to ninety (90) days after its acceptance by NLSIU.
- 14. The University shall issue a work order ("Work Order") to the successful Bidder ("Selected Bidder") within 90 days of opening of the quotations. The Work Order shall consist of terms and conditions, Bill of quantities and drawings (Annexure 4). Acceptance of the Work Order by the Selected Bidder shall form a binding contract with the University.
- 15. Date of start of work shall be reckoned from the date of the issue of the Work Order.
- 16. Payment terms for the work shall be as per the following milestones (i) 30% advance on issue of Work Order, (ii) 30% on completion of supply of materials and (iii) 40% upon completion of the work.
- 17. Any damage to NLSIU property will be made good at Selected Bidder's risk and cost.
- 18. NLSIU will not be held responsible for payment of any compensation to the labourers engaged by Selected Bidder. Selected Bidder will pay all compensations including accident compensations due to its labourers.
- 19. Selected Bidder shall follow all safety rules and security procedure that are in force and applicable during execution of work.
- 20. Selected Bidder shall comply with applicable provisions of all acts, statutes, rules and regulations of Central and State Governments, as the case may be.
- 21. Retention Amount at the rate of 3.5% of the value of the work done for each running account bill will be deducted. The Retention amount will be released to Selected Bidder after completion the defects liability period of 365 days. The retention amount shall not bear any interest whatsoever.
- 22. In case of rejection of material, one more chance will be given for its replacement with the material conforming to the requisite specifications. Any failure of the Selected Bidder to supply materials as per the specifications will result in NLSIU debarring the Bidder from participation in future bids for a minimum period of one year.
- 23. This University reserves the right to cancel this enquiry at any time without assigning any reason.
- 24. The terms and conditions stipulated in this Notice Inviting Quotations are binding on the Bidder.

<u>Specifications for Supply and Installation of Cross link Fence with Gate around</u> <u>Sports field at NLSIU</u>

Fencing Works: Supply , Fabrication and Installation of Chain Link fencing for Sports field consisting of 72x72x4 mm thick MS square pipe in a frame of 3 mtrs width and height of 2 mtrs , fabricated with 2.5mm dia GI wire of 50 mm x50mm size diamond shape chain link mesh with horizontal tie of 50 mm dia in three intervals with one coat primer and 2 coats of enamel paint to complete.

Earthing & Civil Works: Charges towards manual earthwork excavation and Providing of Pedestal size of 300 x300 x 900 (W XH X D) for mounting of fencing poles. Concrete to be M20 grade with standard concrete mixing proportion.

- b. Have been in this Project execution contracting business for more than 5 years and share the similar projects handled for clients. (Please submit relevant documents in the form of Work order /Performance/Completion Certificate from Clients)
- c. Have implemented similar project with overall value of 150% (of the Quote submitted) of the proposed fencing works in NLSIU (Please submit a Certified copy in the form of Work order from the Client duly signed).

Additional Documents Required:

- 1. Overall Financial turnover of the vendor for last 5 years.
- 2. Organization structure & details of team members who will be involved in this Project
- 3. Compliance to Quality of Product/ Service requirements. (Quality Assurance Plan and Process to be implemented for the Project)
