Terms and Conditions:

1. The intending Bidder shall submit the quotes for the enclosed specifications (Annexure 1)
2. Interested bidders may visit and examine the site to acquire the requisite information relating thereto as affecting the quotation upon writing to procurement@nls.ac.in
3. The sealed envelope containing signed copies of Annexures 1 should clearly superscribe "PAINTING AND CIVIL MISCELLANEOUS WORKS AT PROPOSED CRECHE", and shall be addressed to "Finance Officer, Finance Department, National Law School of India University, Gnana Bharathi Main Road, Nagarbhavi, Bengaluru, Karnataka - 560072". The sealed envelope shall be sent to reach this office on or before the due date mentioned, either in person or by Registered Post.
4. GST Registration number and PAN number of the Bidder shall be mentioned in the quotation.
5. Rates quoted by the bidders shall be inclusive of all applicable taxes, including GST. Income Tax and all other statutory deductions like labour cess etc. will be deducted from the payments made as per prevailing rules.
6. The Rate quoted shall be firm and fixed till completion of the entire work & shall not attract any escalation under any circumstances whatsoever
7. The University shall not bind itself to accept the lowest quoted rate. The University shall accept the quotation that is in best interests of the University, as determined by the University authorities. The University reserves the right to not accept any of the Quotations submitted during this process

8. Date of start of work shall be reckoned from the date of the issue of the Work Order.
9. Payment terms for the work shall be as per the following milestones -
 - (i) 30% advance on issue of Work Order and (ii) 70% upon completion of the work.
10. Any damage to NLSIU property will be made good at Selected Bidder's risk and cost.
11. NLSIU will not be held responsible for payment of any compensation to the labourers engaged by Selected Bidder. Selected Bidder will pay all compensations including accident compensations due to its labourers.
12. Selected Bidder shall follow all safety rules and security procedure that are in force and applicable during execution of work.
13. University reserves the right to cancel this enquiry at any time without assigning any reason.
14. The terms and conditions stipulated in this Notice Inviting Quotations are binding on the Bidder.
15. The Work must be carried out within the stipulated completion period, with all due diligence, failing which, Selected Bidder shall be liable to pay a Penalty for Delay of an amount equal to 0.2% of the Contract Value per day of delay. The Total Penalty imposed in the contract period shall not exceed an amount equal to 10% of the Contract Value
