- 3. GST Registration number and PAN number of the Bidder shall be mentioned in the quotation.
- 4. Interested Bidders must make a visit to the site and take a detailed survey as per requirements mentioned and submit the quote accordingly.
- 5. You need to provide 2 client references for the above said work.
- 6. You should have been in the same business at least for 3 years
- 7. Rates quoted by the bidders shall be inclusive of all applicable taxes. Income Tax and all other statutory deductions like labour cess etc. will be deducted from the payments made as per prevailing rules.
