ADMISSION TO LL.M. DEGREE PROGRAMME FOR THE ACADEMIC YEAR 2022-23

The First List of selected candidates for NLSIU notified by CLAT 2022 will be provisionally admitted to the LL.M. Degree Programme for the A.Y. 2022-23.

Document Verification and Other Admission related processes shall be carried out for the selected candidates on **Sunday, July 3, 2022**.

The selected candidates are hereby required to carefully complete the admission formalities set out below.

Step 1: Fill and submit the Admission Form along with the necessary supporting documents

Once the list has been announced, login credentials for the NLSIU Student Portal shall be communicated to the registered Email ID of the candidate as provided in the CLAT portal.

The selected candidates are required to fill the admission form and upload the self-attested copies of the following documents on the NLSIU Student Portal before your Interview Slot.

Documents to be submitted immediately

1. Class X Certificate
2. Class XII certificate
3. LL.B. marks sheet / Degree Certificate [**Note:** Candidates who are yet to receive their degree, will have to fill a declaration on July 3, 2022. Admission will remain provisional until the degree certificate and final marks transcript, indicating that the candidate has met the eligibility criteria, is submitted.]
4. Migration Certificate [**Note:** Candidates who are yet to receive their Migration Certificate, will have to fill a declaration on July 3, 2022. Admission will remain provisional until the submission of certificate.]
5. Medical Fitness Certificate [in the format indicated in Annexure-I]
6. Recent passport size colour photo
7. Caste certificate, if applicable.
8. EWS certificate, if applicable.
9. Disability Certificate, if applicable.
10. Documents relating to qualifying for Karnataka category, if applicable.

11. Any one of the following Government issued Identity Card:

a) Driver's License, b) Aadhaar Card, c) Passport, d) Voter ID or e) Ration Card

Step 2: Fee Payment

Fee payable for 1st year (after deducting the counselling fees already paid to the Consortium of NLUs) by 2nd July 2022.

Step 3 - Document Verification and Admission

Admission formalities and verification of original certificates will be done on Sunday, **July 3, 2022 (1400 hours onwards)** as per the following schedule:

Hour-wise slots will be communicated to students by email after the candidate has submitted the admission form.

All the candidates are compulsorily required to report to the University Campus on July 3, 2022.

The candidates are required to produce the originals of the documents (mentioned above under Step 1) for verification at the time of interview

(kindly note that the original LL.B. Marks sheet and Transfer certificate/Migration certificate will be retained with NLSIU till the completion of the Degree)

The candidates who intend to apply for State / Central Government Scholarship must submit their original Income Certificate.

Step 4: Orientation Programme and Commencement Classes

The Academic year will begin with the Orientation programme for admitted students that shall commence on Monday, 4th July, 2022, at 10 AM. The detailed schedule of the orientation shall be communicated on **Sunday, July 3, 2022**

The classes will commence from Friday, *July 8, 2022 from 8.50 am onwards*. The detailed schedule will be notified to the students during the Orientation Programme.

General Information

- a) Information pertaining to availability of hostel accommodation and the process of application for hostel accommodation shall be notified in due course.
- b) The candidates are required to bring their **parents for the Interview compulsorily**.
- c) After completing the admission formalities, the candidates shall be required to go through a chargeable medical check-up in a health facility prescribed by the University. The details of the medical check-up facility and the schedule shall be notified during the Orientation Programme.

COVID Safety Protocol

- a) Candidates are required to submit Print Copies of COVID Vaccination Certificate and a RTPCR Test negative report from an ICMR approved lab not earlier than 72 hours at the time of the entry into the campus for the admission and document verification on July 3, 2022.
- b) Candidates, regardless of vaccination status, will be required to wear masks in most settings, indoors or outdoors.
