### **ADMISSION TO LL.M. DEGREE PROGRAMME FOR THE ACADEMIC YEAR 2022-23**

The candidates allotted to NLSIU in the Fourth List notified by CLAT 2022 will be provisionally admitted to the LL.M. Degree Programme for the A.Y. 2022-23.

Document Verification and Other Admission related processes shall be carried out for the selected candidates in person on **Monday, July 18, 2022**.

The selected candidates are hereby required to carefully complete the admission formalities set out below.

#### **Step 1: Fill and submit the Admission Form along with the necessary supporting documents**

Login credentials for the **NLSIU Student Portal** shall be communicated to the registered Email ID of the candidate as provided in the CLAT portal.

The selected candidates are required to fill in the admission form and upload the self-attested copies of the following documents on the **NLSIU Student Portal** before your Interview Slot.

#### **Documents to be submitted immediately**

1. Class X Certificate
2. Class XII certificate
3. LL.B. marks sheet / Degree Certificate [**Note:** Candidates who are yet to receive their degree and Migration Certificate, will have to submit a declaration on July 18, 2022. Admission will remain provisional until the degree certificate and final marks transcript, indicating that the candidate has met the eligibility criteria, is submitted.]
4. Migration Certificate
5. Medical Fitness Certificate [in the format indicated in Annexure-I]
6. Recent passport size colour photo
7. Caste certificate, if applicable.
8. EWS certificate, if applicable.
9. Disability Certificate, if applicable.
10. Documents relating to qualifying for Karnataka category, if applicable.
11. Proof of payment to the previously allotted NLU as per the first list
12. Any one of the following Government issued Identity Card:
  - a) Driver's License, b) Aadhaar Card, c) Passport, d) Voter ID or e) Ration Card

## **Step 2: Fee Payment**

**Fee payable for the programme (*after deducting the counselling fees already paid to the Consortium of NLUs and fees already paid, if any, to the previously allotted NLU as per the first list*) by 17th July 2022, 5 p.m.**

## **Step 3 - Document Verification and Admission**

Admission formalities and verification of original certificates will be done on Monday, **July 18, 2022 (1000 hours onwards)**.

**All the candidates are compulsorily required to report to the University Campus on July 18, 2022.**

The candidates are required to produce the originals of the documents (mentioned above under Step 1) for verification at the time of interview

***(Kindly note that the original LL.B. Marks sheet and Transfer certificate/Migration certificate will be retained with NLSIU till the completion of the Degree)***

The candidates who intend to apply for State / Central Government Scholarship must submit their original Income Certificate.

## **Step 4: Orientation Programme and Commencement Classes**

The Orientation Programme for the Admitted Students has been concluded, and the classes have commenced on **July 8, 2022**

### **General Information**

- a) **Hostel Accommodation is not available for LLM Candidates.**
- b) The candidates are required to bring one of their **parents for the Admission Process.**
- c) After completing the admission formalities, the candidates shall be required to go through a chargeable medical check-up in a health facility prescribed by the University. The details of the medical check-up facility and the schedule shall be notified in due course.

### **COVID Safety Protocol**

- a) Candidates are required to submit Print Copies of COVID Vaccination Certificate and a RTPCR Test negative report from an ICMR approved lab not earlier than 72 hours at the time of the entry into the campus for the admission and document verification on July 18, 2022.
- b) Candidates, regardless of vaccination status, will be required to wear masks in most settings, indoors or outdoors.
