#### ADMISSION TO I YEAR B.A., LL.B. (HONS.) DEGREE PROGRAMME

# FOR THE ACADEMIC YEAR 2023-24 AGAINST THE SECOND ALLOTMENT LIST

The Second List of selected candidates for NLSIU notified by CLAT 2023 will be provisionally admitted to the I year B.A., LL.B. (Hons.) Degree Programme for the A.Y. 2022-23.

Document verification and associated processes related to provisional admission shall be carried out between January 28, 2023 and January 29, 2023.

The selected candidates are hereby required to carefully complete the admission formalities set out below.

# Step 1: Fill and submit the Admission Form along with the necessary supporting documents

Once the Second Allotment Llist has been published by the CLAT Consortium, login credentials for the **NLSIU Student Portal** shall be communicated to the registered Email ID of the selected candidate whose names were not included in the First List.

The selected candidates are required to fill in the admission form and upload copies of the following documents on the **NLSIU Student Portal** by 12 noon on **January 28, 2023**.

#### Documents to be submitted immediately

- 1. Class X Certificate
- 2. Class XII certificate or a Declaration in Lieu of It\*
- 3. Migration Certificate or a Declaration in Lieu of It\*
- 4. Medical Fitness Certificate [or a Declaration in Lieu of it]
- 5. Recent passport size colour photo
- 6. Caste certificate, if applicable.
- 7. EWS certificate, if applicable.
- 8. Disability Certificate, if applicable.

- 9. Documents relating to qualifying for Karnataka category, if applicable.
- 10. Any one of the following Government issued Identity Card:
  - a) Driving License, b) Aadhaar Card, c) Passport, d) Voter ID or e) Ration Card

\*Candidates who are yet to write their Class XII Examination shall submit a Declaration to the effect that the Class XII Examination Marksheet and Certificate and the Migration Certificate shall be submitted on or before September 30, 2023 and that admission will remain provisional until the submission of certificate and marksheet indicating that the candidate has met the eligibility criteria.

Please note that only the following authorities competent to issue Caste Certificates, OBC-Non-Creamy Layer Certificates and Economically Weaker Section (EWS) Certificates:

- District Magistrate/ Additional Magistrate/ Collector/ Deputy Commissioner/ Additional Deputy Commissioner/ Deputy Collector/ Ist Class Stipendiary Magistrate/ Sub-Divisional magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner (not below the rank of Ist Class Stipendiary Magistrate).
- Chief Presidency Magistrate / Additional Chief Presidency Magistrate / Presidency Magistrate.
- Revenue Officer not below the rank of Tehsildar' and
- Sub-Divisional Officer of the area where the candidate and/or his family resides

For Karnataka Students Category seats, submission of study certificates issued by duly recognised and affiliated Schools, which attest that the candidate has completed at least 10 years of schooling in Karnataka is mandatory.

#### Step 2: Interview with Academic Administration Staff

An interview slot shall be notified to each selected candidate by email. The interview slots shall be scheduled on: January 28 between 2.00 - 5.00 pm.

The candidates shall be required to join the Zoom meeting room at the notified slot. Though each interview may not take longer than 5 minutes, candidates may be required to be online for the duration of the slot notified.

#### Step 3: Communication of Acceptance of Documents to Candidate

If all the documents uploaded are found to be in order, the University shall send to the candidate an emailed communication of acceptance of documents.

#### Step 4: Payment of Confirmation Fee to CLAT Consortium

Candidates must pay the Confirmation Fee as per the instructions of the CLAT Consortium within the stipulated time in the Admissions Counselling Calendar released by the CLAT Consortium - before January 31 10:30 P.M.

#### Step 5: Fee Payment

The option of Payment of University Fee (after adjusting for Confirmation Fee and Counselling Registration Fee) by all candidates who have chosen the Freeze Option in the counselling process for First and Second Allotment Lists (first and second rounds of counselling) shall be opened on February 1, 2023.

The fee may be remitted through the payment gateway provided in the NLSIU Student Portal via any of the following instruments.

- Credit Card
- Debit Card
- Net Banking Options
- Demand Draft
- RTGS

The details of the **Financial Aid Policy and Financial Aid Application Forms** will be available on the NLSIU Student Portal.

Candidates who have chosen the Freeze Option in the counselling process for First and Second Allotment Lists (first and second rounds of counselling) and are desirous of financial aid in terms of the NLSIU Financial Aid Policy are required to submit their application on or before March 15, 2023, 11.59 p.m.

The University shall communicate its decision on the financial aid application form around May 1, 2023.

All candidates who have chosen the Freeze Option in the counselling process for First and Second Allotment Lists (first and second rounds of counselling) are required to make the Payment of University Fee on or before May 20, 2023, 11.59 p.m.

#### Step 6 - Interaction with Vice Chancellor and Registrar

The student along with their parents/ guardians will be invited to attend a short introductory interaction with the Vice Chancellor and the Registrar over Zoom. Details will be separately notified to students who select the Freeze Option.

# Step 7 - Original Document Verification, Admission, Orientation Programme and Commencement of Classes

The verification of original certificates and completion of admission-related processes, and the Orientation Programme shall be held in person in June 2023. The exact dates shall be notified in due course.
