## NOTIFICATION

### ADMISSION TO LL.M. PROGRAMME

### FOR THE ACADEMIC YEAR 2023-24 AGAINST THE FOURTH ALLOTMENT LIST

**The candidates allotted to NLSIU in the Fourth Allotment List for NLSIU notified by CLAT 2023** will be provisionally admitted to the LLM Programme for the A.Y. 2023-24.

Document verification and associated processes related to provisional admission shall be carried out between June 6, 7, and 8, 2023

The selected candidates are hereby required to carefully complete the admission formalities set out below.

#### **Step 1: Fill and submit the Admission Form along with the necessary supporting documents**

Once the Fourth Allotment List has been published by the CLAT Consortium, login credentials for the **NLSIU Student Portal** shall be communicated to the registered Email ID of the selected candidate included in the Fourth List whose names were not included in the previous lists.

The selected candidates are required to fill in the admission form and upload copies of the following documents on the **NLSIU Student Portal** by 12 noon on **June 6, 2023**.

#### **Documents to be submitted immediately**

1. Class X Certificate
2. Class XII Certificate
3. LLB Degree Certificate or a Declaration in Lieu of It\*
4. Migration Certificate or a Declaration in Lieu of It\*
5. Medical Fitness Certificate [or a Declaration in Lieu of it]
6. Recent passport size colour photo
7. Caste certificate, if applicable.
8. EWS certificate, if applicable.
9. Disability Certificate, if applicable.
10. Documents relating to qualifying for Karnataka category, if applicable.
11. Proof of payment to the previously allotted NLU as per the first list or the second list

12. Any one of the following Government issued Identity Card:

- a) Driver's License, b) Aadhaar Card, c) Passport, d) Voter ID or e) Ration Card

***\*Candidates who are yet to write their LL.B. Examination or who have not received their marksheet shall submit a Declaration to the effect that the LLB Examination Marksheet and Certificate and the Migration Certificate shall be submitted on or before September 30, 2023 and that admission will remain provisional until the submission of certificate and marksheet indicating that the candidate has met the eligibility criteria.***

Please note that only the following authorities competent to issue Caste Certificates, OBC-Non-Creamy Layer Certificates and Economically Weaker Section (EWS) Certificates:

- District Magistrate/ Additional Magistrate/ Collector/ Deputy Commissioner/ Additional Deputy Commissioner/ Deputy Collector/ Ist Class Stipendiary Magistrate/ Sub-Divisional magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner (not below the rank of Ist Class Stipendiary Magistrate).
- Chief Presidency Magistrate / Additional Chief Presidency Magistrate / Presidency Magistrate.
- Revenue Officer not below the rank of Tehsildar' and
- Sub-Divisional Officer of the area where the candidate and/or his family resides

For Karnataka Students Category seats, submission of study certificates issued by duly recognised and affiliated Schools, which attest that the candidate has completed at least 10 years of schooling in Karnataka is mandatory.

### **Step 2: Interview with Academic Administration Staff**

An interview slot shall be notified to each selected candidate by email. The interview slots shall be scheduled on: June 6, June 7 and June 8 between 4.00 - 5.00 pm.

The candidates shall be required to join the Zoom meeting room at the notified slot. Though each interview may not take longer than 5 minutes, candidates may be required to be online for the duration of the slot notified.

### **Step 3: Communication of Acceptance of Documents to Candidate**

If all the documents uploaded are found to be in order, the University shall send to the candidate an emailed communication of acceptance of documents.

#### **Step 4: Fee Payment**

To secure their seat, the candidate has to pay the Adjusted University Fees, as defined below:

Adjusted University Fees shall mean the **University Fee, after adjusting for Confirmation Fee and Counselling Registration Fee and any fee paid to the previously allotted NLU as part of first or second round of counselling.**

The Adjusted University Fee for the respective student shall be uploaded as an invoice request on **the NLSIU Student Portal** after verification of documents and communication of Acceptance of Documents to Candidate.

**The fee may be remitted through the payment gateway provided in the NLSIU Student Portal via any of the following instruments.**

- **Credit Card**
- **Debit Card**
- **Net Banking Options**
- **Demand Draft**
- **RTGS**

All candidates who have chosen the Freeze or Float Option in the counselling process in the Fourth Round of Counselling are required to make the Payment of Adjusted University Fee **on or before June 10, 2023, 10.30 p.m.**

The details of the **Financial Aid Policy and Financial Aid Application Forms** will be available on the NLSIU Student Portal.

Candidates allotted to NLSIU in Fourth Allotment List who are desirous of financial aid in terms of the NLSIU Financial Aid Policy are **required to submit their application on or before June 18, 2023, 11.59 p.m.**

**Please note that candidates are required to pay the full Adjusted University Fee by June 10, even if they seek to apply for financial aid.** In case, their application for financial aid is approved, the amount for which financial aid has been granted shall be reimbursed.

The University shall communicate its decision on the financial aid application form around June 30, 2023.

**Step 5 - Original Document Verification, Admission, Orientation Programme and Commencement of Classes**

The verification of original certificates and completion of admission-related processes shall be done on June 30 2023. The exact timings shall be notified in due course.

**General Information**

- The University shall confirm by June 15 whether housing on campus shall be provided for out-station candidates.
- Candidates, who have their current or permanent address in Bengaluru, shall not be provided on-campus housing.
