- 1. The intending bidders shall submit the quotes as per details mentioned above via email to procurement@nls.ac.in on or before **Saturday**, **August 12**, **2023 by 5.00pm**.
- 2. All the item/s should supply on or before Monday, August 28, 2023 by 5.00pm.
- 3. Rates quoted by the bidders shall be inclusive of all applicable taxes, including GST, Income Tax and other statutory deductions like labour cess etc. will be deducted from the payments made as per the prevailing rules.
- 4. GST Registration number and PAN Number of the Bidder should be mentioned in the quotation.
- 5. The Bidder should provide a Defect Liability Period (DLP) of minimum 1 year for the products mentioned above.

- 6. The University shall not bind itself to accept the lowest quoted rate. The University shall accept the quotation that is in the best interests of the University, as determined by the University authorities. The University reserves the right to not accept any of the Quotations submitted during this process.
- 7. The University shall issue a Purchase Order ("PO") to the successful Bidder ("Selected Bidder") with in 7 days of opening of the quotations. Acceptance of the PO and its terms and conditions by the selected bidder shall form a binding contract with the University.

Payment terms for the work shall be as per the following milestones -

- 8. 100% payment will be released on completion of the installation and training and on certification of the tax invoice by the IT Department.
- 9. Rates for the items/s shall remain valid for ninety days from the date of submission of the bid.
- 10. The terms and conditions stipulated in this Notice Inviting Quotations are binding on the Bidders.
