#### Terms and Conditions:

- 1. The intending Bidders shall submit the quotes for the enclosed specification (Annexures 1)
- 2. A consolidated amount (inclusive of taxes and all other charges) is to be submitted in the form of email quotation to NLSIU. Email Quotations will be accepted up to 5.00 PM on 30.11.2023. You may send the email quotation to procurement@nls.ac.in.
- 3. Rates quoted by the bidders shall be inclusive of all applicable taxes, including GST. Income Tax and all other statutory deductions like labour cess etc. will be deducted from the payments made as per prevailing rules.
- 4. GST Registration number and PAN number of the Bidder shall be mentioned in the quotation.
- 5. The Bidder should provide a Defect Liability Period (DLP) of minimum 1 year for Projectors supplied to NLSIU.
- 6. The Rate quoted shall be furn and fixed till completion of the entire work & shall not attract any escalation under any circumstances whatsoever.
- 7. The University shall not bind itself to accept the lowest quoted rate. The University shall accept the quotation that is in the best interests of the University, as determined by the University authorities. The University reserves the right to not accept any of the Quotations submitted during this process.

- 8. The University shall issue a Purchase Order to the successful Bidder ("Selected Bidder") within 30 days of opening of the quotations. The PO shall consist of terms and conditions, specification (Annexures 1). Acceptance of the PO by the Selected Bidder shall form a binding contract with the University.
- 9. Date of start of work shall be reckoned from the date of the issue of the PO.
- 10. Payment terms for the work shall be as per the following milestones -
  - 50% of the total PO value will be paid as advance after the PO is issued.
  - The balance of 50% will be settled with the final bill.
- 11. Any damage to NLSIU property will be made good at Selected Bidder's risk and cost.
- 12. NLSIU will not be held responsible for payment of any compensation to the labourers engaged by Selected Bidder. Selected Bidder will pay all compensations including accident compensations due to its labourers.
- 13. Selected Bidder shall follow all safety rules and security procedure that are in force and applicable during execution of work.
- 14. Selected Bidder shall comply with applicable provisions of all acts, statutes, rules and regulations of Central and State Governments, as the case may be.
- 15. The Work must be carried out within the stipulated completion period, with all due diligence, failing which, Selected Bidder shall be liable to pay a Penalty for Delay of an amount equal to 0.2% of the Contract Value per day of delay. The Total Penalty imposed in the contract period shall not exceed an amount equal to 5% of the Contract Value.
- 16. The terms and conditions stipulated in this Notice Inviting Quotations are binding on the Bidder.
