1) WHAT DO WE DO WITH YOUR INFORMATION?

When you pay fees, we collect personal information such as your name, address, and email address.

When you browse our website, we also automatically receive your computer's internet protocol (IP) address to provide us with information that helps us learn about your browser and operating system.

2) CONSENT

How do you get my consent?

When you provide us with personal information to complete any fee remittance transaction or verify your credit card, we imply that you consent to our collecting and using the personal information for that specific reason only.

How do I withdraw my consent?

3) RETENTION

How long will my data be retained?

The personal information so collected shall be retained only for a limited duration necessary to fulfill the purposes for which the data was collected unless a longer retention period is required or permitted by law. Notwithstanding the foregoing, we may retain all academic and other relevant non-academic records and information that are required or deemed necessary to be retained for fulfillment of the University's academic, research and administrative functions.

4) **DISCLOSURE**

We may disclose your personal information if we are required by law / regulatory authorities to do so.

5) PAYMENT

We use Razorpay for processing payments. We/Razorpay do not store your card data on their servers. The data is encrypted through the Payment Card Industry Data Security Standard (PCI-DSS) when processing payment. Your fee payment transaction data is only used as long as is necessary to complete your fee payment transaction. After that is complete, your fee payment transaction information is not saved.
