Full-Fledge Audio/Video Solution for In-room audio amplification (audio lift) and also support for Audio/Video conferencing using popular conferencing platform. The requirement is for two conference rooms housed one above another.

#### Scope Includes

- Supply of Mikes either Gooseneck, Table Mic: 20 Each for CR 1 and CR2
  - Tabletop mics should be wireless and using Li-ion Batteries with min speak time of 8 hours
  - o Li-ION charging station for en-masse charging should be provided.
  - The mics should have individual on/off control.
  - o The microphone should be capable of movement across the CR 1 and CR2 seamless with little or no intervention.
