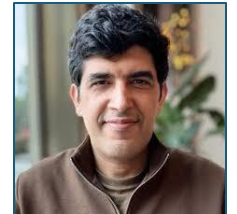
Confluence Guide: Sidharth Chauhan, Assistant Professor of Law and Assistant Dean - Research, NLSIU
