1. Objective of the RFP:

To engage a contractor/vendor to do the electrical works as mentioned in the scope of works.

2. Scope of Work:

Electrical Works for Provision of Power from Service Yard, Library to Football Ground at the University premises.

3. Schedule Completion Date:

The timeline to complete the work is on or before **3 Weeks from the date of issue of Purchase Order.** All the above-mentioned works needs to be completed with all the snag points resolved and handover needs to be done on or before the said date.

- **6.** The selected bidder must comply with all applicable laws, rules, and regulations set by Central Governments, State Governments, Local Authorities or any other Government Authorities.
- **7.** The Bidder must submit the GST Registration Certificate, PAN copy and MSME Certificate (if applicable) along with the quotation. If the bidder is not registered under MSME, a self-declaration needs to be submitted.
- **8.** Interested Bidders are requested to make a visit to the site and take a detailed survey as per BOQ enclosed and submit the quote accordingly.
- **9.** The Bidders need to provide 3 client references for the supply and installation of similar furniture in FY 2025-26 if required by the University later during the bid evaluation stage.
- **10.** The Bidders should have been in the same business at least for 5 years.
- **11**. The Rate quoted shall be firm and fixed till completion of the entire work & shall not attract any escalation under any circumstances whatsoever.
- 12. The Rate quoted by the Bidder shall remain valid up to ninety (90) days after its acceptance by NLSIU.

13. Payment Terms:

<u>Advance</u>: Only to the extent of 50% of the total work order if decided mutually.

<u>Final Payment</u>: The balance amount will be released after successful completion of the work and upon certification by the Project Manager.

- 14. Any damage to NLSIU property will be made good at Selected Bidder's risk and cost.
