

## **Call for Applications | Manager - Litigation Fellowships**

The National Law School of India University (NLSIU) invites applications for a full-time (contractual) role of a Manager - Litigation Fellowships for a period of one year (extendable based on performance). The role will be based out of the NLSIU Bengaluru campus (with occasional travel).

### **A. About the Fellowship Programme**

The NLS Litigation Fellowship Programme will support early career, first-generation litigators in developing their litigation practice. Fellows will be able to access mentorship, robust training programmes, and networking opportunities that will allow them to become leaders in the field of litigation.

The Fellowships Manager will report to the Director-Clinics and Fellowships, and work under the supervision of the Assistant Director- Litigation Fellowships.

#### **Key Responsibilities**

- Coordinate the process of the selection and onboarding of litigation fellows each year
- Oversee the development and periodic updation of the fellowship curriculum
- Conduct periodic fellowship reviews with litigation fellows
- Design, coordinate and conduct the biannual fellowship meetings
- Writing annual fellowship review reports
- Maintain systematic record of meetings, workshops and other planned activities
  - Serve as staff liaison to the fellowship advisory group and develop group annual work plans, including application review and selection and quarterly meetings to solicit recommendations and guidance on program activities.
- Foster strong communication with and among current and former fellows and mentors via email, social media, in- person meetings, and other interactions.
- Manage programme budgets.
- Any other tasks as required

#### **Reporting**

The Manager will report to the Director, Clinics and Fellowships.
