NOTIFICATION

ADMISSION TO 1st YEAR B.A., LL.B. (HONS.) DEGREE PROGRAMME

FOR THE ACADEMIC YEAR 2026-27 AGAINST THE FOURTH ALLOTMENT LIST

The candidates selected for NLSIU as notified by CLAT 2026 in the Fourth Allotment List will be admitted provisionally to the 1st year of B.A., LL.B. (Hons.) Degree Programme for the Academic Year 2026-27.

Document verification and associated processes related to provisional admission shall be carried out on May 4, 2026 between 1400 hours to 1700 hours.

The selected candidates are hereby required to carefully complete step-wise admission formalities stated below:

Step 1: Fill and submit the Admission Form along with necessary supporting documents

Once the Fourth Allotment List has been published by the CLAT Consortium, the admission form for uploading documents shall be shared with the selected candidates via their registered email IDs provided by the CLAT Consortium by **1400 hours on May 2, 2026**.

The selected candidates are required to fill in the admission form and upload copies of the following documents by **1000 hours on May 4, 2026**.

List of documents to be submitted:

1. CLAT 2026 Admit Card (signed by the invigilator).
2. Class X Marksheet.
3. Class XII Marksheet or a Declaration in Lieu of it*
4. Recent passport size colour photo.
5. Caste certificate, if applicable.
6. EWS certificate, if applicable.
7. Disability Certificate, if applicable.
8. Karnataka Study Certificate, if applicable.

9. Any Government-issued photo identity card such as a) Driving License, b) Aadhaar Card, c) Passport, d) Voter ID Card, e) Ration Card, or f) PAN Card.

Candidates who were admitted into any other NLU through any previous round of CLAT Counselling and have paid the University Fees to such University must also upload the receipt of payment of such fees.

****Candidates who are yet to write their Class XII examination or have not yet received their marksheet are required to submit a Declaration to the Effect that the Class XII Examination Marksheet shall be submitted on or before September 30, 2026 and that the admission shall remain provisional until the submission of the certificate and the marksheet indicating that the candidate has met the eligibility criteria. [See Annexure I] Candidates who have written their Class XII examination in 2025 or earlier must submit their Class XII Marksheet.***

Please note that only the following authorities are competent to issue Caste Certificates, OBC-Non-Creamy Layer Certificates, and Economically Weaker Section (EWS) Certificates:

- District Magistrate/ Additional Magistrate/ Collector/ Deputy Commissioner/ Additional Deputy Commissioner/ Deputy Collector/ 1st Class Stipendiary Magistrate/ Sub-Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner (not below the rank of 1st Class Stipendiary Magistrate)
- Chief Presidency Magistrate/ Additional Chief Presidency Magistrate/ Presidency Magistrate
- Revenue Officer not below the rank of Tehsildar, and;
- Sub-Divisional Officer of the area where the candidate and/ or his family resides.

For Karnataka Students Category seats, only study certificates issued by duly recognized and affiliated schools, which attest that the candidate has completed at least 7 years of schooling in the state of Karnataka, shall be accepted.

EWS Certificate must not be older than a year as on January 07, 2026.

OBC-Non-Creamy Layer Certificate must be a valid certificate. Where no date of validity/expiry is mentioned in the certificate, the certificate must not be older than a year as on January 07, 2026.

Step 2: Interview with the Academic Administration (AAD) staff

An interview slot shall be notified to each selected candidate by email for online document verification. The interview slots are scheduled on **May 04, 2026 between 1400 and 1700 hours through Microsoft Teams.**

The candidates are required to join the Microsoft Teams meeting room at the notified slot. Candidates should ensure that they join the meeting at the designated time and have the original copies of all documents submitted ready for verification. While the verification itself may take no more than five minutes, they may need to remain available online for the entire duration of the assigned time slot.

Step 3: Communication of Acceptance of Documents to Candidate

If all the documents uploaded are found to be in order, the University will send the candidate an email communication confirming the provisional acceptance of the documents.

Step 4: Payment of Confirmation Fee to CLAT Consortium

Candidates must pay the Confirmation Fee, if not already paid, as per the instructions of the CLAT Consortium within the stipulated time frame in the Admissions Counselling Calendar released by the CLAT Consortium- on or before 1300 hours on **May 08, 2026.**

Step 5: Payment of Fee

The payment of the University Fee, after adjusting for Confirmation Fee and Counselling Registration Fee and any fee paid to the previously allotted NLU as part of any previous round of CLAT 2026 Counselling, shall commence on May 09, 2026. All candidates who select the Freeze Option during the counselling process must pay the University Fee on or before May 30, 2026, 1700 hours to confirm the admission, regardless of whether they have applied for financial aid or not. Failure to pay the fees by the due date (i.e., **May 30, 2026 by 1700 hours) will result in the cancellation of provisional admission.**

The **University Fee amount**, after adjusting for the Confirmation Fee and Counselling Registration Fee and any fee paid to the previously allotted NLU as part of any previous round of **CLAT 2026 Counselling**, for candidates who select the Freeze Option in the counselling process is as follows:

The details of the Fee structure and the Financial Aid Policy are also available on the University website. The Financial Aid Application Forms shall be emailed to the candidates. The fee may be remitted through the **payment gateway/ bank account of the University**, which will be emailed to the candidates after provisional acceptance of documents.

Applying for Financial Aid

Candidates who select the Freeze Option and wish to apply for financial assistance under the University's Financial Aid Policy are required to submit their application on or before **June 15, 2026, 2359 hours**. However, before submitting their application for University's financial aid, they **must** apply under the PM Vidyalaxmi Scheme.

NLSIU has been recognised by the Government of India under the PM Vidyalaxmi Scheme as one of the leading higher educational institutions in the country and students of NLSIU are eligible for applying under this scheme.

The PM Vidyalaxmi Scheme provides collateral-free and guarantor-free education loans to meritorious students. There is no income limit to apply for this scheme, and loans up to INR 30 lakhs can be availed. Partial and full interest subvention is available for lower annual family incomes. Decision on Financial Aid Application

The University will communicate its decision on the financial aid applications by July 31, 2026. Students who are provided financial aid shall have their fee reimbursed up to the extent of the aid provided.

Step 6: Original Document Verification, Admission, Orientation Programme and Commencement of Classes

The verification of original certificates and completion of admission-related processes shall be conducted on June 28, 2026. All candidates are required to report to the NLSIU Campus in

Bengaluru with at least one of their parents on the day. Orientation programme shall commence on June 30, 2026. The exact schedule shall be notified in due course.

General Information

- All outstation candidates selected for the B.A., LL.B. (Hons) Programme shall be provided residential accommodation.
- Candidates whose CLAT 2026 Admit Card shows a Bengaluru address will be treated as Bengaluru residents, and they will be given residential accommodation subject to availability.

- Admission of all candidates shall remain provisional until verification of original certificates and completion of admission-related processes on campus on June 28, 2026.
